








## **Perfectly** Situated

400 University is a Class A jewel box perfectly situated for single- or multi-floor users, offering level A parking privileges, unmatched access to and from I-5, branding opportunities, and security. The building is part of the larger Rainier Square project, comprising 1.2 million SF of office space, farm-fresh restaurant Mendocino Farms, 191 luxury apartments, and a seven-level underground garage.

400 University is connected to Rainier Square and Rainier Tower via the second floor Grand Hall, offering direct access to the light-filled library and inner courtyard with both outdoor and indoor fireplaces, as well as The Fonté Bar, a modern café serving house-roasted coffee, breakfast and lunch fare, and evening wine and cocktails.
